

## Selection of HRDC Breeding Lines (F4-F6)

March 18 and 20, 2014

7:00AM - 5:00PM

- 1 **SELECTION KIT** (inside the meeting bag with the program booklet) is available in your booked accommodation.  
*BP International* - claim at the Front Desk upon check in  
*IRRI MSS Hall* - claim at the Matron's Office upon check in

Selection Kit: Guidelines, Field Map, HRDC Selection List, Summary Sheet of Selected Lines  
Selection Tags, Pencil & Marker Pen

Selection Code: Codes provided to selection participants are confidential. The code is attached on the folder at the upper right part. Only Ms. Charisse can decode & identify who made the selection.

Selection Tag: Assigned Code is already written in the tags. **Use the marker pen in writing the 2014DS# in the tag.** Do not use pencil or ballpen. This will be used as reference in case the tag is not firmly attached on the plant. Please DO NOT write your company name in the tag.

**Number of Selections allowed** (1 tag = 1 selection)

Private Sector A = 100

Private Sector B = 50

Public Sector = 50

Proceed to HRDC Office if additional selection tags are needed. \$100 per line will be charged for extra selection.

- 2 HRDC Annual Meeting ID is attached in the bag with the program and selection kit.  
**Please bring/wear your ID all the time inside IRRI premises.**  
Participants at *BP International*, coaster is ready at **7:00AM** (refer to HRDC shuttle service schedule inside the program booklet) and will bring you to the Selection Field. For those staying at *IRRI MSS Hall*, Selection Field is walking distance.
- 3 Proceed to **Block C14, C13, C12 and D12**. HRDC Staffs will be in the field to assist you. Strictly follow the Selection Schedule. No extensions will be allowed.
- 4 Mark the plant selected in the **HRDC Selection List** provided. Write the 2014DS# in the Selection Tag using the marker pen. **Firmly attach the tag in the plant selected.**
- 5 Complete the information on the **Summary Sheet**. Submit the hard copy list/summary to Charisse or Annie right after you finish the selection. This will be our reference in verifying the plants selected during harvest period. **Seeds will not be harvested without the summary sheet.**
- 6 Plants with tag in the field will be verified based on summary sheet. We will notify you if there is discrepancy on the list. Then, final list with quantity of the seeds to be applied in the import permit will be sent to the participant. **Deadline in receiving import permit (hard copy) is on June 30, 2014. All seeds will be destroyed after the deadline.**
- 7 Materials are expected to be dispatched in IRRI after 6 weeks upon receipt of required documents (Routine Seed Health Testing & documents processing).

### Important Reminders:

- Participants are **NOT allowed to harvest** any seeds. Previously, we found out that some members secretly harvested seeds or cut the whole plants. This action is against all HRDC Members. Please observe strict compliance. Violators will be apprehended.
- Participants should be cautious NOT to stomp on other plants or destroy other plants whether selected or not. Other members and IRRI Breeders are making selections too!
